10. MINUTES OF THE 2020 JANUARY 28 REGULAR BOARD MEETING

a. Confirmation of Minutes

11. STUDENT TRUSTEE UPDATE

Student Trustee Chun reported the Ontario Student Trustees Association is working on an equity survey noting the data will be compiled into a Provincial document.

Student Trustee Butler provided an update on the previous Student Advisory Meeting noting K. Appleby facilitated a session on student mental health. Student feedback was well received noting the importance of the student voice. Collated student responses will be discussed at a future meeting.

Student Trustee Kennedy reported she attended the FNMI Student Leadership Council where she led a blanket exercise, guided discussion and spoke about her role.

12. REPORTS FROM ADMINISTRATION

a. Presentation of the Mid-Year Operational Plan Report

M. Fisher presented the Mid-Year Operational Plan Report summarizing the progress on the Strategic Priorities.

Trustee Skinner extended his appreciation for the level of detail in the report acknowledging the progress to date.

b. Student Information System Implementation

J. Pratt presented for approval a commitment of \$5,266,000.00 from the accumulated surplus internally appropriated for IT Technology and Infrastructure that will support the transition to, and implementation of, the Board's new Student Information System. It was noted the go live date is targeted for 2021 September.

After 2021 August 31 the current Student Information System (SIS) Trillium platform will no longer be supported requiring the need to move to a new platform. A project plan and budget has been developed to support this transition.

Questions of clarification regarding Ministry funding, replacing classroom computers, testing the new platform, oversight of the project, the cost variance, project timelines, risks of the plan, IT costs and staffing were addressed.

Trustee Skinner reported the transition to the new Student Information Systems at Boards across the Province was addressed at OPSBA acknowledging the project is long overdue.

In response to a question, it was noted the new platform is a cloud based program.

14. TRUSTEE UPDATES FROM EXTERNAL COMMITTEES

a. Ontario Public School Boards' Association (OPSBA)

Trustee Skinner provided an update on OPSBA reporting the Education Labour Relations and Human Resources Symposium will be held 2020 April 30 - 2020 May 1. Additional information is available for Trustees in the Trustee Conference room.

Trustee Skinner advised many other boards have written the Minster of Education requesting action regarding vaping. Trustee Skinner attended a presentation about Coronavirus preventative measures.

Trustee Skinner reported Take Your MPP to School Day will be held the week of 2020 April 13, noting MPPs M. McNaughton, J. Yurek and P. Sattler intend to participate.

Trustee Skinner reported the Directors voted in favour of establishing a one-year \$500.00 scholarship for Student Trustees. The criteria for consideration will be determined by the OPSBA OSTA Liaison Committee.

A report was presented at OPSBA regarding teacher supply and demand by the Deans of Education and the Directors of Education working table. Key items were reviewed noting the report is available for Trustees in the Trustee Conference room.

Trustee Skinner reported several Boards have written letters to the Province voicing their stance on various issues of concern in education.

The content of the letter was considered.

Trustees in favour of the motion provided their rationale noting this is a way to advocate for students. Trustees spoke to the need to communicate publicly on the stance of the Board of Trustees.

Trustees speaking against the motion support OPSBA as the Trustees voice at the table suggesting sending a letter may weaken that voice. It was noted any letter should be sent to OPSBA. Concerns were identified that Trustees were not provided adequate time to review the letter and provide input.

It was suggested the letter be shared with other Board Chairs, MPPs and OPSBA. Through discussion Trustees determined it was important to include student voice in the letter.

Student Trustee Chun contributed content for the letter on behalf of the Student Trustees. "On behalf of myself, Student Trustee Erica Butler, and Indigenous Student Trustee Chiara Kennedy, we fully support this letter to the Minister of Education, Stephen Lecce. Our priority as Student Trustees is to advocate for TVDSB students, and we feel it is our duty and responsibility to reflect these local concerns at the Provincial level. "

> THAT the Chair write a letter on behalf of the Board of Trustees to the Minister of Education to draw attention to our ongoing concerns with proposed education changes. Specifically, the letter will address our ongoing concerns with proposed class size ratios and impacts on pathways and programs and mandatory e-learning. Specifically that the TVDSB Trustees prefer a 22:1 class size ration, expect unfunded liabilities to be fully funded including Special Education, absenteeism, student transportation and capital projects. The TVDSB Trustees oppose mandatory online learning as a broad based policy and recognize that teachers are our most valuable asset in student success. Our letter will also highlight the need for all parties to use positive dispute resolution means and to return to the bargaining table for ongoing dialogue in the best interest of students in our Board and across the Province.
