| Content: | The above September Board motion was discussed by the PASSA Committee and Planning and Priorities Advisory (PAPA) Committee Chairs, and their staff designates. It was decided the conversation around community engagement as it relates to the MYSP would best take place at a PASSA meeting as the PASSA workplan has the capacity for the item. The process to rescind the previously adopted Community Engagement motion would be as follows: 1. Recommendation from the PAPA Committee to the Board to rescind the September Community Engagement motion 2. During the PAPA Committee report, the Chair will make a motion to temporarily suspend the Special Rules of Order with the intended purpose of voting on the pending motion as per TVDSB Bylaw 10.2.1. The motion to suspend the Special Rules of Order can only be adopted with a 2/3 vote and the rules would only be suspended for that agenda item. |

| | NOTE: As per TVDSB Bylaws Appendices, Special Rules of Order 3.3.3, "Following the adoption of a motion, the motion may not be rescinded during the current Board term or within a period of 12 months, whichever is the lesser." As a result, before the motion to rescind is introduced at the November Board meeting, 3. Once the motion to suspend the Special Rules of Order is adopted, the motion to rescind the September Community Engagement motion would be put on the floor during the PAPA Committee report to the Board. 4. As per TVDSB Bylaws 10.2.2, the Board Governance and Bylaw Review Committee will review section 3.3.3 of the Special Rules of Order Appendix and report back to the Board at the January 2025 meeting. 5. The conversation around community engagement as it relates to the MYSP would be added to a future PASSA Committee meeting agenda. |
