1. Call to Order

Vice Chair Morse called the meeting to order at 1:32 p.m. A roll call was requested and conducted.

A question of clarification was addressed by the Chair regarding quorum for the meeting.

2. Conflicts of Interest

None declared.

3. Approval of the Agenda

Without objection, the agenda was approved.

Superintendent Bruce introduced Paul Boniferro, who was appointed by the Ministry of Education as the Thames Valley District School Board's (TVDSB) Supervisor.

Supervisor Boniferro shared information about his background and mandate.

Questions of clarification were addressed by Supervisor Boniferro regarding letters that are sent to the Ministry from the Special Education Advisory Committee (SEAC) and the communication process when decisions are made that affect the TVDSB.

4. Minutes of the Previous Meeting

On motion, the minutes of the 2025 April 7 regular and in-camera meetings were approved as printed.

5. Unfinished Business

a. Letter - Speech Language Pathology Presentation (7)

Vice Chair Morse led a discussion regarding a letter to be written to the Ministry of Education concerning wait times for Speech and Language Pathology (SLP) services.

Discussion included referencing budget constraints in the letter and forming a collaborative approach between Interim Director Tucker and the SEAC when drafting the letter.

A housekeeping amendment changing the name "Peter Calandra" to "Paul Calandra" was made prior to the motion being put on the floor.

The following motion was moved by member Pecican and **ADOPTED**:

THAT the Interim Director of Education at the Thames Valley District School Board write a letter to the Minister of Education, Paul Calandra, and Minister of Children, Community and Social Services, Michael Parsa, highlighting concerns regarding wait times for Speech and Language Pathology (SLP) services from community agencies; and

THAT an integrated service delivery model for SLP services be considered to enhance efficiency, accessibility, and outcomes for students.

6. 2025-26 Preliminary Budget - Special Education

Superintendent Lynd and Manager Macey presented the 2025-26 Preliminary Budget – Special Education for feedback. Year-over-year changes in the budget were outlined.

Questions of clarification were addressed by Administration regarding staffing allocated to blind and low vision students and psychological support services, calculations utilized for the budget revenue lines, the budget approval process given the supervision of the TVDSB by the Ministry of Education, enrolment and its effect on budget numbers, and deferred revenue.

Vice Chair Morse provided the rationale for the motion.

Members requested a review of agenda item #7 Special Education Plan Standard 12 in advance of voting on the motion.

Questions of clarification pertaining to Standard 12 were addressed by Administration regarding attendance counselors, the timeline for approving the Special Education budget, and the budget for Teachers on Special Assignment.

The following recommendation was moved by member Fortnum and **CARRIED**:

WHEREAS after reviewing the Special Education budget, the Special Education Advisory Committee (SEAC) notes significant concerns regarding the impact of provincial budget reductions on the ability to provide services for students with Special Education needs, and

WHEREAS the SEAC appreciates the commitment of the Ministry of Education-appointed Supervisor in continuing to support Special Education and our most vulnerable students by supporting a deficit.

THAT the SEAC endorses the 2025-2026 Preliminary Special Education Budget to be approved by the Ministry of Education-Appointed Supervisor.

A vote to extend the meeting until 3:15 p.m. was defeated.
